Purposes of the Association

The Association does not contemplate pecuniary gain or profit of the members thereof. The purposes for which the Association is formed are to carry out the purposes and exercise the powers to be described and provided for the Association in the Declaration of Covenants, Conditions, Restrictions and Easements for The Cottages at Shock Hill to be recorded in the office of the Clerk and Recorder of Summit County, Colorado, as amended or supplemented from time to time (the "Declaration"). Capitalized words or terms used in these Articles and not defined herein shall have the meaning provided for them in the Declaration.

Powers of the Association

In furtherance of the purposes stated above, the Association shall have and may exercise all of the rights, powers, privileges, and immunities now or subsequently conferred upon nonprofit corporations organized under the laws of the State of Colorado or granted under the Declaration.

Distribution of Assets Upon Dissolution

If the Association is dissolved, its assets shall be distributed equally to the members.
