TANNHAUSER MANAGEMENT ASSOCIATION

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation under the Colorado Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name or title by which the corporation shall be known in law is: "Tannhauser Management Association".

II.

The period of its duration is perpetual.

III.

The particular business and objects for which this corporation is formed are as follows:

1. To govern the condominium prop. situate in the County of Summit, State of Colorado, which is called Tannhauser Condominium Apartments, and which is described in Exhibit A of the By-Laws.

2. To take and hold by bequest, devise, gift, purchase, or lease, either absolutely or in trust for any of its purposes, any property, real, personal or mixed, without limitation as to amount or value thereof, and while the owner thereof, to exercise and enjoy all of the rights, powers and privileges of ownership to the same extent as a natural person might or could do; to operate, use, enjoy, manage, improve, mortgage, pledge, lease, assign, sell, transfer, convey or otherwise dispose of any such property; to invest and reinvest its funds, either principal or income, in any securities or property of whatsoever character deemed proper by its directors for such investment; and, generally to employ, donate and expend the property and funds of the corporation for the purposes thereof as specified in the preceding paragraphs of this Article III.

3. To make, enter into and perform contracts of every kind and description, necessary, advisable or expedient in carrying out the purposes of the corporation, with any person, firm, association, corporation, municipality, body politic, county, state or government.

4. To have one or more offices and to conduct and carry on any of its business at any place in the State of Colorado, as may be determined by its managers.

5. In addition to the above enumerated purposes and objects, this corporation shall have all powers granted by the laws of the State of Colorado.

IV.

No member shall have any right, title or interest in the assets of the corporation, and in the event of dissolution, the assets of the corporation shall be liquidated as quickly as possible, the liabilities of the corporation paid, and the balance of the funds on hand shall be donated to a like corporation which is organized not for profit.

V.

The address of the initial registered office of the corporation shall be 1487 South Oakand Street, Aurora, Colorado 80010<sup>10</sup> and the name of its initial registered agent at such address is Jerry O. White.

VI.

The number of managers who shall conduct and manage the business and affairs of the corporation shall be four (4), unless enlarged by the By-Laws of the Association, and the following are hereby designated as managers of the corporation during the first year of its existence or until their successors are duly elected and qualified:

No manager of the corporation shall receive any pecuniary profit from the corporation or its operations, no member of the corporation shall receive any pecuniary profit from the corporation or its operation except reasonable compensation for services performed in effecting one or more of its purposes.

VII:

Qualifications for membership in the corporation shall be set forth in the By-Laws, which shall describe the powers and duties of the managers of the corporation, and the managers or members of the corporation, as may be provided in the By-Laws, shall have the power, from time to time, to make, alter and amend such prudential By-Laws as they shall deem proper for the management of the business and affairs of said corporation.

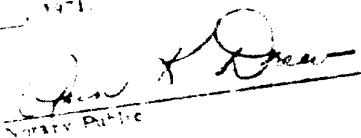
