I. Welcome

Homeowners who opted out of the remediation will not be included in the repairs. The Board is looking to hire a GC; AE will supply information for any GCs on file.

Fred informed the Board that he spoke with the Town of Frisco regarding creating a permanent location for those living out of their vans/cars. Ten spots in the transit center lot are on the list of possibilities. Fred will send all homeowners the information from the Town Council meeting, so they are aware.
